Alejandro Avila – San Joaquin Boxing Club is asking for city assistance in providing a space for a gym for their boxing club so the kids will have access to activities to stay away from gangs, gang activity and stay off the streets. Participants are more educated in lots of ways mentally and physically. They now have 7 fighters and 7 trainers who represent San Joaquin, 16 participants and they would like to provide a stable gym for local youths. It would help to have a gym here Huron and Avenal have one. They don't charge for training but enjoy it when they win. The Association of Boxing has a license and the fighters are registered and it's not just a club.

Juan – Elm Street – He is a boxer has fought 6 fights lost 1 and he had training in his garage and he now borrows a shop to offer boxing training with no money from anybody. He stated prior the city had programs from 2:30-6:00 every day and it stopped because the kids didn't have a ride. Help them to help the kids. He will be participating in Hanford on the 29 & 30.

Juan Echeverria – Asking for city support to provide indoor soccer and is asking to use the community center. There is no entertainment for kids and inside soccer would be able to help approx. 40 kids.

Guadalupe Torres – He would like to invite the people to a marathon on 9/16, wants the city to contact President Trump to get cell phones and he stated the owner of the store needs to talk to the police and to help them they are resting, sleepy and it's hot from 3-4.

Jose Lopez – Stated we are in deficit with bad management need to not turn away people who need to work we will fight and we will win.

Anna – 22121 Railroad Ave – Thanked city staff for helping her mother who owns the home. Squatters broke in their vacant house stealing water, kids destroying her yard, squatters caused a fire in the house and destroyed their home. Sheriff did nothing when they were called and she stated squatters have more rights, the sheriffs were horrible and threatened the homeowner.
